


Sidebar Agreement
Between
Ocean Township Board of Education and
Township of Ocean Transportation Association

The Ocean Township Board of Education (Board) and Township of Ocean Transportation Association(Association) agree to the following:

1. The Board and Association agree to establish language regarding Extra Runs for Drivers for the 2022/2023 school year, as follows:
 - Drivers who are interested in signing up for Extra Runs will be added according to seniority. If said drivers run coincides with their regular run the district will offer their run to another driver if available or a substitute driver. Extra Run/Overtime will be paid at straight time with only additional compensation for the time beyond their regularly scheduled run.
2. Item #1 of this Side Bar Agreement shall be incorporated into the Collective Bargaining Agreement.
3. All other terms of the current Collective Bargaining Agreement shall remain in full force and effect until otherwise agreed upon by the parties.


